Sponsored by ABIMED, LCA Consultores developed a study that measured the gains in social welfare resulting from technological increment. According to the study, the Medical Technology Index has a positive impact on the cost of healthcare. A 1% increase in the index positively impacts per capita health spending by 0.494%. Between 2009 and 2019, the increase in medical technology caused health spending to rise by R\$97.68 billion (ANS + SUS). In terms of well-being, it was found that a 1%...



The workshop brought together representatives from the public and private spheres to analyze how technology helps in the treatment of cancer patients - a disease that affects 700 thousand new cases every year — and the trends for the future.

In this issue, we also look at how compliance promotes a culture of integrity in all areas of healthcare, making it essential to guarantee the standards of ethics, transparency and responsibility demanded by public authorities, regulatory agencies and consumers.

In Education, we address the need to update the curriculum of the Country's Medicine courses to include, among other aspects, digitalization and the use of technology. In a recent Deloitte survey, 44% of physicians pointed out that courses should cover the use of data and 43%, training in new technologies.
